POOL PARTY RULES AGREEMENT

Thank you for your interest in having a party! We look forward to helping you with Lifeguards and Pool area reservations to keep your guests safe while they have fun. Please read, initial and sign the following rules agreement, then follow the directions at the bottom of this agreement. Use a separate form for EACH party. Feel free to call us with any questions.

►► Please initial all spaces below:

_____ Daytime Pool Party:

1. Parties may be reserved at a facility managed by Advantage Pool Management during normal pool operating hours.
2. Public Pool Parties have a one (1) lifeguard minimum and for every twenty (20) guests an additional lifeguard will be required. This is IN ADDITION to the regularly scheduled lifeguards.
3. Lifeguards are billed for at the rate of twenty-five dollars (\$25.00) per hour, per lifeguard.
4. A thirty-five dollar (\$35.00) non-refundable administration fee applies to this type of party.
5. Please note that a pool CANNOT be closed to the public during open hours for a Public Pool Party.

_____ After Hours Pool Party Rental:

1. Exclusive parties may be hosted at a facility managed by Advantage Pool Management outside of normal operating hours.
2. After-Hours Pool Rentals require at least two (2) lifeguards to be present at the rate of twenty-five dollars (\$25.00) per hour, per lifeguard.
3. A fifty dollar (\$50.00) non-refundable administration fee applies to this type of party.

► Party & Event Policies

_____ Cancellations:

1. Non-weather-related cancellation of a party or event must be occur at least twenty-four (24) hours prior to party reservation.
2. Weather-related cancellations must occur at least one (1) hour prior to the reservation.
3. Cancellation of a party or event after the minimum time required by this policy will be billed for one (1) hour of lifeguard labor.

_____ Length, Time & Lifeguards:

1. Parties and events must be at least two (2) hours in length and may not be held after midnight (12 a.m.).
2. A minimum of two (2) lifeguards are required for all After-Hours Pool Rentals regardless of the number of guests attending.
3. Additional lifeguards will be required with a ratio of one lifeguard per twenty (20) guests inside the pool's gated area regardless of whether or not they will be swimming.
4. If the number of guests attending the party inside the pool's gated area exceeds the maximum number agreed upon, Advantage Pool Management will assign an additional lifeguard and the customer will be billed accordingly.

_____ Food/Drinks:

1. Alcohol is not allowed at any party or event where Advantage Pool Management Lifeguards are present.
2. No Glass containers allowed on pool property.
3. Food and snacks are allowed
4. Non-alcoholic beverages are allowed

_____ Additional:

1. Smoking is not allowed on pool property at any time
2. Pets are not allowed
3. Each child who is unable to swim MUST have one adult per child at the party, regardless of whether or not the child will be in the pool
4. The adult for any child unable to swim must be within arms reach of the child at all times, in or out of the water

Clean-Up & Closing Procedures:

The clean-up duties that the customer hosting the party is responsible for are:

1. The proper disposal of all trash
2. The clean-up of any messes left by the occupation of their guests
3. The return of all pool furniture items to their original locations.

Ten (10) minutes prior to end of the scheduled reservation time, the Advantage Pool Management personnel on duty will evacuate the pool and begin pool closing procedures.

In the event that the party extends beyond the reserved ending time, including any required additional clean-up tasks incurred by Advantage Pool Management lifeguards, a charge for the additional time will be assessed and billed to the customer.

► Party & Event Information:

Daytime Public Pool Party

- *1 Lifeguard Per 20 Party Guests (Swimming or not)
- *1 Lifeguard Minimum
- *\$25 /hr (per lifeguard)
- *\$35 Administration Fee (non-refundable)

After Hours Public Pool Party

- *2 Lifeguards for up to 20 Party Guests (Swimming or not) & 1 guard per 20 guests over the initial 20
- *2 Lifeguard Minimum
- *\$25 /hr (per lifeguard)
- *\$50 Administration Fee (non-refundable)

► Reserve Your Party/Event:

1. Fax or email this entire agreement to hold your party's date and time
2. Make check payable to Advantage Pool Management. Mail check and **this entire original signed agreement** to the address at the top of this form.

***We must have payment and this agreement before we can officially reserve your party.**

-Please allow at least 5 days notice after we receive this form and payment. We will contact you to finalize and verify that we have received the original form and payment and that the party is reserved and scheduled.

-All parties are reserved on a first-come, first-served basis.
